In reference to your letter cited at Ref No. 5 above, we are submitting the compliance to Engineer's Inspection Report to accord NONO to the proposed vendor.

Kindly Note:

1. Point (a), clause 4 is already acceptable to Engineer.
2. Point (b), Clause 4 pertains to extension of RDSO certification. Vendor has already applied for same. Copy of same is attached in Annexure 1
3. Point (c), clause 4 is already acceptable to Engineer
4. Point (d), clause 4 pertains to Calibration of Tensile Tester. Same is not required in Expansion Joints Testing. Explanation for same has been enclosed in Annexure 2
5. Point (e), clause 4 is acceptable to Engineer. However no rubber related testing is required in Expansion Joints as per the Engineer approved drawings (Refer Annexure 2)
6. Point (f), Clause 4 is already acceptable to the Engineer.
7. Point (g), Clause 4 pertains to strip seal. Strip seal is not required in Expansion Joints as per Engineer Approved Drawings. Refer Annexure 2 for explanation.
8. Point (h), Clause 4 pertains to QAP as per clause 14.5.6.2 Volume III. Expansion Joints from M/s Ameen Ji fulfils the above criteria. Strip Seal criteria mentioned in clause 14.5.6.2 Volume III of CA is not relevant to Expansion Joints. (Refer Annexure 2)
9. Point (i), Clause 4 acceptance as per Contract Agreement Volume III Clause 14.5.6.2 is explained vide attached Annexures 1 to 3.
10. Point (j), Clause 4 pertains to MTC & Invoice which are enclosed in Annexure 3
11. Point (k), Clause 4 Pertains to usage of Anchor Loops & steel from another brand. Refer Annexure 3 for MTC and Invoices from approved brands. ISA test reports from NABL III party are also enclosed
12. Point (l), Clause 4 pertains to chloroprene which is not relevant to Expansion Joints.
